1. The procurement shall be completed in accordance with the PPRA Rules 2004, on Single Stage – Two Envelope Bidding Procedure.
2. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the PMU School of Dentistry SZABMU, Children Hospital, PIMS Islamabad during office hours Monday to Friday (09:00 AM To 03:00 PM) on nonrefundable payment of Rs. 10,000/- in the form of Pay Order in favor of "School of Dentistry" SZABMU Islamabad, from **29<sup>th</sup> June 2018** till **19<sup>th</sup> July, 2018**. Bidders are allowed to acquire Bidding document for any/all package(s).
3. The pre-bid meeting will be held on **6<sup>th</sup> July, 2018** at 11:00 am, in PMU Office of School of Dentistry.
4. A single package containing Technical and Financial Separate Bids, duly completed, signed stamped, sealed and in complete conformity with Tender Document should be dropped, in PMU School of Dentistry SZABMU, Children Hospital, PIMS Islamabad, not later than **11:00 AM** on last date, i.e., **19<sup>th</sup> July, 2018** of submission of bids and bids shall be opened at **11:30 AM** on the same date.
5. An earnest money equal to 2% of the Total Bid Value should accompany the bid as part of financial proposal in the form of bank guarantee, bank draft, CDR drawn in favor of School of Dentistry, Shaheed Zulfiqar Ali Bhutto Medical University, Islamabad. The bid shall not be considered without earnest money.
6. **Only authorized dealer, registered partner for equipment mentioned in BOQ can participate.**
7. **The bidder can quote for any or all packages given in the tender document.**
8. **The bid must comply with all items of individual package. Incomplete package will straightaway be rejected.**
9. Bids which are incomplete, not sealed, not signed, without bid security and not stamped, late or submitted by other than specified mode will not be considered.
10. Income/Sales tax registration certificate and other documents as mentioned in Tender Document must accompany the bids.
11. All applicable Government Taxes shall be deducted as per law. Proof of registration with Income Tax and Sales Tax Departments should be enclosed with the Bid.
