Bidders are allowed to participate in any/all package(s).
3. The pre-bid meeting will be held on **15<sup>th</sup> June, 2020** at 10:00 am, in PMU Office of School of Dentistry.
4. A single package containing Technical and Financial Separate Bids, duly completed, signed stamped, sealed and in complete conformity with Tender Document should be dropped, in PMU Office, School of Dentistry SZABMU, Islamabad, not later than **11:00 AM** on last date, i.e., **18<sup>th</sup> June, 2020** of submission of bids and bids shall be opened at **11:30 AM** on the same date.
5. An earnest money equal to 2% of the total Bid Value should accompany the bid as part of financial proposal in the form of bank guarantee, bank draft, CDR drawn in favor of School of Dentistry, Shaheed Zulfiqar Ali Bhutto Medical University, Islamabad. The bid shall not be considered without earnest money.
6. **The bidder can quote for any or all packages giving in the bidding document.**
7. **For Materials, the company must have DRAP registration.**
8. Bids which are incomplete, not sealed, not signed, without bid security and not stamped, late or submitted by other than specified mode will not be considered.
