- 1. The procurement shall be completed in accordance with the PPRA Rules 2004, on Single Stage Two Envelope Bidding Procedure.
- The Purchase Office now invites sealed bids through e-Pak Acquisition & Disposal System (e-PADS) (<u>https://eprocure.gov.pk</u>) from eligible consultancy firms registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue.
- 3. The Firm/Individual must have the valid enlistment with **IESCO** and having valid **PEC CONSULTANCY LICENSE**.
- 4. The bidding shall be conducted through "Single Stage-Two Envelope" bidding procedure as per Rule 36(b)(ii) of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or instructions issued by the authority (from time to time) and is open to all potential bidders. The envelopes should be marked as Technical Bid and Financial Bid in bold legible letters in separate envelopes.
- 5. Bid(s) must be accompanied by a **Bid Security** of the amount which is being appeared at e-PADS against this activity, as per PPRA Rule 25. in an acceptable form as given in the respective bidding document as well as appearing at e-PADS. The scanned copy of Bid Security must be uploaded through e-PADS and hardcopy must be submitted physically as instructed below.
- 6. Bidding Document containing detailed terms & conditions of the bidding process, can be downloaded from <u>https://eprocure.gov.pk</u> free of cost.

7. The bid(s) prepared in accordance with the instructions mentioned in the procurement activity's Bidding Document, must be submitted through e-PADS at <u>https://eprocure.gov.pk</u> by or before 1000 hours PST on the closing date for procurement activity mentioned above. Whereas, the Bid Security instrument, in original, in sealed envelope, duly mentioning the Name & Ref. Number of the procurement activity on the envelope, must be delivered at the aforementioned address one day before the bids' submission due date & time. The Technical Bids at e-PADS will be opened at 1030 hours PST through e-PADS on the closing date for procurement activity in the presence of bidders' representatives who shall choose to attend the bids' opening session to be held at Syndicate Hall, Shaheed Zulfiqar Ali Bhutto Medical University, 5<sup>th</sup> Floor School of Dentistry, Adjacent to CPSP Building, Ravi Road, G-8/3, Islamabad.

- The Bid Security Amount of <u>Rs. 100,000/- (One Hundered Thousand Rupees)</u> should accompany the bid as part of financial proposal in the form of bank draft, CDR drawn in favor of, <u>Shaheed Zulfiqar Ali Bhutto Medical University</u>, <u>Islamabad</u>. The bid shall not be considered without bid security or less than mentioned amount.
- 9. Bidders must submit **PEC CONSULTING ENGINEER** license certificate with bidding document and must be **enlisted in latest list of PEC approved consultants working with IESCO**.
- 10. Bids which are incomplete, not sealed, not signed, without bid security and not stamped, late or submitted by other than specified mode will not be considered.
- 11. Income and Sales tax registration certificate and other documents as mentioned in Tender Document must accompany the bids. The Bidder must be Active Taxpayer at FBR ATL List.
- 12. Financial bid will be considered if the bidder is technically responsive to mandatory criteria.
- 13. All applicable Government Taxes shall be deducted as per law. Proof of registration with Income Tax and Sales Tax Departments should be enclosed with the Bid.
