S. R. O. 702(I)/2022.— In exercise of powers conferred by sub-section 30 of the Shaheed Zulfiqar Ali Bhutto Medical University Act, 2013 (XV of 2013) read with of the Shaheed Zulfiqar Ali Bhutto Medical University (Amended) Act, 2018 (III of 2018), the Senate on the recommendations of Syndicate of SZABMU, hereby makes the following amendments in Rules;

"Time scale formula and grant of higher scale promotion is placed as addition in Employees Service Rules of Shaheed Zulfigar Ali Bhutto Medical University, Islamabad.

Regular employees serving in BPS-01 to BPS-20, shall be eligible for grant of time scale promotion to next rank or grade with pay and allowances attached with that rank or grade on completion of length of service and one year above of as mentioned in Rules, subject to the terms and conditions mentioned below:

- (1) on occurrence of vacancy against substantive post, within the promotion share, the employee already granted the time scale promotion shall be considered for promotion against the said post on the recommendations of DPC as per Rules. In case of deferment or supersession, the time scale promotion of the employee shall remain intact;
- (2) time scale promotion shall be admissible once during the whole service of an employee.
- (3) In case of retirement or death of the incumbent during service, he shall be eligible for grant of pensionary benefits of the holding time scale promotion;
- (4) The recruitment Rules, nomenclature of the posts and seniority of the employees shall remain intact.
- (5) The grant of Higher Scale through above time scale formula will be subject to fitness of candidates and recommendations of the relevant DPCs and Selection Boards.

- (g) Appendix-4 (114) (2), **Computer Allowance** –The words "Rs.300 p.m." is replaced with the words "Rs.750 p.m.".
